The U.S. General Services Administration (GSA) issued a Request for Proposals for the fourth generation of its broker and leasing support services contract, GSA Leasing Support Services (GLS) Plus. The new contract provides earlier customer engagement, increased pre- and post-lease award services, and the introduction of time and cost saving technologies. GLS Plus is expected to generate approximately \$129 million in rent credits to tenant agencies and significantly reduce lease cycle times by eliminating workload redundancy.
